A Dramatic dead lock is anticipated in the second phase of the resumed talks between the Srilankan Government and the Tamil United Liberation Front delegation headed by its boss Mr. Amirthalingam.

With the T.U.L.F. firmly declaring its stand on the question of 'Tamil Homeland' and the continuing adamant and arrogant attitide of the Jayawardane Government to keep the northern and eastern provinces apart, it is increasingly clear that the outcome of the talks is hinged on this sole question of one single tamil province.

Inspite of Mr. Amirthalingam's well known and equally well understood inclination, right from the beginning to have a negotiated settlement at the earliest convenient opportunity, there is no denying the fact that the T.U.L.F. leadership, by and large, is very sensitive and responsive to the settlements and sensitivities of the tamil militants.

Apart from the roaring realities of the present volatile situation leading to the realisation that any political solution arrived at without the participation of and in the midst of oppostition from the Tamil Eelam Militant movements would soon be dead than it is found, there is also a growing feeling and awareness among the TULF leadership that if not for the sacrifice on the part of the young patriots, the racist and repressive regime of Jayawardene could not have been forced to keep its option for a political solution open, the indomitable Indian factor being the other reason

That is why a couple of former MPs who were and are in the T.U.F. delegation to Colombo were very much upset over the hasty and careless comments of their boss, about his inability to meet the militant leaders on the eve of the team's departure to Colombo on the first occasion, with two solid days inbetween.

Most of the T.U.L.F. leaders based in Madras are very well aware of the potential problems and inevitable consequences of further alienating the militants, who have openly expressed their 'reservations' in regard to the T.U.L.F.'s participation in the talks being held on the basis of the draft proposals outrightly rejected by all of them. Also these leaders pretty well know that they are not the people to pronounce the final word on any agreement that might be reached between the Srilankan Government and them.

Though Mr. Amirthalingam has been isolated in this regard for quite sometime now, being a shrewd politician knowing when to hug and when to hit, the emerging consensus among his erstwhile unquestioning colleagues was not lost on him. Further more, with the silent reservations shared by many of his close colleagues over the past two years in regard to the conducting of affairs on his part, slowly but steadilv shaping into open and very often unpelatable criticism in the Politbureau meetings in the recent past, it is no wonder that Mr. Amirthalin-



ADIEU! ASSASSINATION POLITICS

On the 27th of July 1975, the then Mayor of Jaffna, the top most traitor to the Tamil race and the conspiring collaborator of the racist regime of Srimavo Bandaranayake – the infamous Alfred Thangarajah Thuraiappa was gunned down.

No patriotic Eelam Tamil asked why. For he knew why and also knew that, that was how it should be.

Again on the 26th of May 1981, Arumugam Thiagarajah – Former M.P. for Vaddukkoddai, the man who inflicted the stunning defeat on the so-called invincible Appappillai Amirthalingam in the latter's formidable fortress in 1970, contesting in the Tamil Congress Ticket and subsequently defected to the ruling Srilanka freedom Party to get ignominously rejected by his electorate seven years later and the leader of the United National Party's list of candidates in the District Development Council elections for Jaffna in 1981 – succumbed to the gunshot injuries sustained the previous night during an election meeting.

No patriotic Eelam Tamil asked why. For he knew why and also knew that, that was how it should be.

The peace-loving Tamil people had by then attuned and aclamatised to the atmosphere of violence thrust upon them by successive governments of Sinhala Chauvinism. Their youth had started to fight a liberation struggle and the physical elimination of their traitors was unavoidable though unfortunate. After all, it had been part and parcel of all liberation struggles all over the world.

But later, in the same year of 1981, when Sivashanmuga Moorthy alias Suntharam a militant youth with praiseworthy political acumen was shot dead in broad day light in a busy street in the Bazaar area, of Jaffna Town,

When in 1982, Iraikumaran and Umaikumaran, the inseparable militant twins – not by birth, but by heart and soul became inseparable in death also, when they together fell victims to a volley of shots in the thick of night,

When in 1983, 'Obroi Thevan', the leader of the Tamil Eelam Liberation Army – T.E.LA., admired for his determination amply demonstrated by his 'dare-devil' attacks on the Sinhala Governmental targets was awarded the death penalty one dizzy afternoon,

And in 1984, Jegan – the leader of T.E.L.E., a very small militant organisation beginning to get name and fame for its military manoeuvres was 'hit' and killed in an encounter explained to have arisen out of 'mistaken identity,

The patriotic Eelam Tamils asked why and what for.

The fanatical but forceful answers forwarded to explain these fratricidal killings failed to cut any ice with the intelligent and shrewd tamil people.

The murky mysteries initially clouding each and every one of these meaningless murders ultimately gave way to the rational realisation on the part of the tamil people that the young tamil patriots who had taken up arms to fight the common enemy or rather the enemy had started murdering each other forsaking and forgetting the aim and objective of their getting armed.

In between these incidents of fraternal foul-play leading to fratricidal ferocity, quite a good number of traitors who were betraying the tamil people in their struggle for survival as a separate and distinct nation were handed over death penalties.

Pulendran – the unsuccessful U.N.P. candidate for Vavuniya Electorate in the General Elections of 1977 who continued to be its belligerent organiser till his last,

Rajasooriar – the mayoral candidate for Jaffna on behalf of U.N.P. and a long time local politician with the dubious distinction of conspiracy and connivance in the Commission of Rape and Murder of an unmarried and unrelenting young post-mistress,

Gnanachandran – a former Magistrate notorious for his non-judicial verdicts based on partiality and an incumbent Government agent who colluded and conspired with the Sinhala racists for his own sake of position, power and promotion,

And their alike, more than three dozen in number were given their passports to the 'other' World and promptly packed off.

Not a whimper of protest was heard from the civilised and sensitive tamil people, for treachery had no place in their midst.

Then came 1985 September.

Two former M.Ps. of the Tamil United Liberation Front – T.U.L.F. – Messrs. Alalasuntharam and Dharmalingam were shot dead.

The Tamil people with one voice condemned this senseless violence in no uncertain terms. Their realisation earlier in regard to the killings of young tamil patriots was concretised into a conviction this time with these cold-blooded double murders and fervent hopes were raised that this incident would serve as an eye-opener for all tamil militants.

But alas! the tragedy struck again.

This time it was not a case of just one or two, but the mass murder of more than one hundred and thirty tamil patriots – all in the flower of their youth – along with a few politically conscious civilians followed by the assasination of their leader Sri Sabarathinam.

The tamil conscience awakened and alert did not fail to register its unqualified protest in unambiguous terms to this most unfortunate and unprecedented holocaust in the political history of tamils in the island of Srilanka.

The Eelam Tamils were in no mood to lend their ears to the conflicting and confusing theoretical justifications dished out in the form of doctoral declarations in defence of these despicable acts and ensconced in excessively exuberant verbosity exposing streaks of intellectual insanity.

If we, Eelam Tamil Militants are prepared to do a thorough soulsearching at this juncture, the sole and solid answer that would surface as the sordid cause in each one of all these cases of cold-blooded murder is shockingly identical — politics of a dangerous kind — **assasination politics.**

We are neither Cowards not hypocrats to mince words in this regard.

We would like to look at the problem directly and squarely.

We, the young tamil militants of Eelam, had not only been killing traitors, but also our compatriots in the name of patriotism.

In other words all those unfortunate patriots who fell victims in fratricidal conflicts and confrontations had been assasinated for patriotism, by patriotism and unbashedly, out of patriotism.

Let us be clear on one basic fact.

Patriotism is nobody's monopoly.

Let there be, no mistake about it.

In as much as one Eelam patriot can love his fatherland, another too can – no less, no more.

Our dead compatriots consigned to the consuming flames of fratricidal fire are no more with us. But their ideal is – yet to be achieved.

For the fulfilment of their and our lofty ideal, let us forget the past and jointly and unitedly look forward to a new future.

To begin with, let us sincerely, solemnly and truly declare:

ADIEU! ASSASINATION POLITICS!

KARAINAGAR CREATES HISTORY

gam has been the target of adverse and angry comments about his abrasive and arrogant attitude towards the militants, unmistakably manifested in his undiplomatic explanation of lack of time to talk to the militants. Also he has been made to understand the emotional involvement of most of his colleagues with the question of Tamil Homeland.

Mr. Amirthalingam knows that he cannot afford any internal revolt within the politbureau at this critical juncture when he is very hopeful of clicking an agreement with Jayawardene.

It is aagainst this background that the T.U.L.F. chief declared quite eloquently and emphatically in Madras recently at the National convention on Srilanka organised by the Akila Bharathiya Vidyarthi Parishad that there shall be no compromise on the question of tamil homeland, comprising of both northern and eastern provinces.

It was a safe and shrewd move on the part of Mr. Amirthalingam viewed in the context of the retaliatory blow he received from the Eelam National Liberation Front when it politely but firmly declined the offer of the TULF politbureau inviting the former for a 'meeting'. psychological reaction on the part of E.N.L.F. was, in appreciated by some former MPs who are in the delegation to Colombo and who are unrelenting on the question of Tamil Homeland.

At the same time, Srilankan President Jayawardene has been blowing hot and cold, in his typical style over the prospects of a negotiated political solution with his sinister and shrewd stand quite clear on the question of Tamil Homeland.

With the less or no religious and more political monks from the monasteries getting mobilised for marches and morchas against the proposals of provincial autonomy and with the wily and cunning widow Srimavo, the leader of S.L.F.P. assisted by her playboy – bachelor son Anura all out to exploit the present situation to pay back Jayawardene with the same coin, and with the appearance of 'bombs' at the residences of trotskyite L.S.S.P. leader Colvin R de Silva and

S.L.M.P. leader and Srimavo's son-in-law, actor-cum-Politician Vijayakumaranatunga, co-operating with the Government to buy peace for the Sinhala race, the patriarch of Sinhala-Buddhist Chauvinism is going to find his task to convince the Sinhala masses susceptible to the slightest communal provocation, very very difficult.

The Role of the proscribed Janata Vimukti Peramuna, the architect of the abortive insurgency of 1971, in these circumstances is not yet clear, though it's unseen hand is strongly suspected in the latest developments, especially the planting of bombs.

There is another force, namely Ranasinghe Premadasa, the Prime Minister well known for his notorious anti-Indian rhetoric some time past, noticeably silent now. Premadasa, at 62, with his chances of succeeding Jayawardene who will turn 80 next month, becoming slimmer and slender with the sudden and subtle entry of the oldman's only son Captain Ravi Jayawardene, suspected to be propelled and promoted by the father, into the race for succession along with powerful and very ambitious ministers Lalith Athulath Mudali and Gamini Digsanayake already in the field, is faced with the most crucial decision in his political career.

The Commoner turned Capitalist Premadasa may do another C.P. de. Silva, if he finds the mounting opposition to the proposed provincial autonomy plan gathering enough momentum provided he is also convinced that there is no chance of his achieving the crowning of his career by remaining with the Government.

If he does it, the impact of such a step would be immense and enough to torpedo the talks and its outcome. But it should not be forgotten that Premadasa always measures his steps.

Already a front has been launched comprising of S.L.F.P., M.E.P., and other pan-Sinhala organisations and the monks. In the event of Premadasa and his private army joining this unholy alliance, which would naturally be aided and abetted by the Marxist J.V.P., it could lead to an explosive situation that would plunge the isaland paradise into a blood bath.



SELVAM SUCCEEDS OUR 'SRI ANNA'

Selvam (24) has been entrusted with the unenviable task of leading the Tamil Eelam Liberation Organisation after the assasination of its leader Sri. Sabarathinam.
