Press Statement

Our efforts to contest under PA symbol on a non contest basis, while keeping our basic principles ~~is~~ including,

1. The opposing to open economic policy of allowing the plunder by the multinational corporations,
2. The defence of the right of self determination of tamil people and the opposition to genocidal war in the North,

was thwarted by the PA leadership.

There is no clear answer to the letter to Mr. D.M. Jayaratne, PA general secretary, on 27.06.94.

Under these conditions we have decided to contest separately in a few districts where we have a base. In this effort we hope to come to an agreement with Janatha Vimukthi Peramuna, SL Progressive front, Muslim Progressive front and other militant parties. We hope to arrive at an agreement to contest jointly a few selected districts, where we could get elected. On this basis we expect to put forward a joint list to Colombo in the name of NSSP and the symbol, Umbrella.

In all other districts, excluding those where we would contest jointly, we shall give critical support to the PA and we will continue to be in the ~~to~~ fore front of the struggle to oust the UNP regime.

Comrade Vasudeva Nanayakkara and those other party members who are working against the party programme and the CC decisions on 03.07.94. are considered to have abandoned the cause of the party, and the party will not be responsible and not binding what soever on their activities.



Press Statment.

Announcing the holding of a snap Parliamentary Election on 16th August 1994 (as against in February 1995 as is contitutionally due) President Wijetunge has made it know^N that elections will be held even in the Jaffna District which is the main theatre of the war that goes on in the North East. Death and destruction still go on unabated with an economic blockade also still in place. We therefore condemn the decision of the Government to hold elections in that area and that too by clustering Pelling Stations in the small area which constitutes the Islands Division that has been "cleared". This is very paently a sinister design on the part of the Government to resort to heavy rigging to its own advantage.

It is incumbent upon all parties that stand for democracy, free and fair elections to protest against and boycott the elections in the North where the people live in terrific fear for their lives.
