Listing of Non Agricultural Economic Activities - 1995

A. Introduction

Listing of Non Agricultural Economic Activities was conducted in stages in Rural Sector covering all districts except the districts in Northern & Eastern Provinces. The main objective of this exercise was to identify the building material producing units and to compile the value of construction output of the housing sector as required by ICTAD. However, in order to make the exercise complete all non agricultural activities were enumerated.

A Grama Niladhari (GN) Division or a part of GN Division was considered as an enumeration area and enumerators were appointed by the Divisional Secretary of the area. The enumerator prepared a list of non agricultural economic activities by visiting each and every building in the enumeration area under the supervision of District Statistical Staff and the Head Office Staff.

B. Coverage

i. Economic Activities

The following Economic Activities were covered by the listing of non-agricultural economic activities.

1. Mining and Quarrying
2. Manufacturing
3. Electricity, Gas production & Water supply
4. Construction
5. Trade, Hotels and restaurants
6. Transport, Communication & Storage
7. Finance, Insurance, Real estate and business services
8. Public Administration, Education & Health activities
9. Community and Social Service & Private service activities

ii Area

This listing operation covered only the rural sector in Sri Lanka and did not cover:

1. Northern and Eastern Provinces
2. All Municipal Councils and Urban Councils
3. Areas covered by the Board of Investment

C. Listing Operation

The recruited enumerators were given a two days training by panel of trainers selected and trained for that purpose in advance. An enumerator is assigned to each enumeration area which is usually a GN Division . When the GN Division is spread over a larger area or has a large number of housing units / buildings, the GN Division is divided into two enumeration areas.

The enumerators were asked to complete one line in the listing form (L) for each housing unit / building with the following information.

1. Name of the owner proprietor of the enterprise/chief occupant
2. Postal address
3. Nature of the unit
4. Type of Economic activity
5. Type of construction activity
6. Number of residents

If the housing unit/building was having the activities on

1. Mining and quarrying
2. Manufacturing

The following further information is inserted to the L1 form.

1. Economic Organization of the Establishment
2. Type of ownership of the establishment
3. Type of Industry
4. Major Products produced by the establishment
5. Persons engaged in the industry

Further if the housing units/building had done some construction activities during the reference period that too were included in an another form called L 3 with the following additional information.

1. Type of the Construction Activity done during the period from January to June in 1995
2. Expenditure/Estimated expenditure incurred during the period
3. Source of funds

D. Preparation of Tables

The information collected by the enumerators through L1 form was checked for completeness and data coded by the range Statistical Investigator under the supervision of the District Statistician/Statistical Officer. When two major products were given for an establishment, both products were coded using the information available in column 6 & 7. However the code for the 1st product is considered as the code relevant for the whole establishment in the tabulation procedure.

In most of the districts, data entry was done at the District Office itself using the personal computers available there. However L1 forms relevant to few districts were fed to the computer by the Data Processing Division of the Department.

The tabulation was done by the Industry and Construction Division using the SPSS PC+ package. The tables consist the number of establishments and the persons engaged by Divisional Secretary Division and ISIC two digit level (Revision 3) in one set and ISIC 4 digit level (Revision 03) at district level in the other set. In cases when it is felt that the individual identification is disclosed, the information is either combined with another category or suppressed.

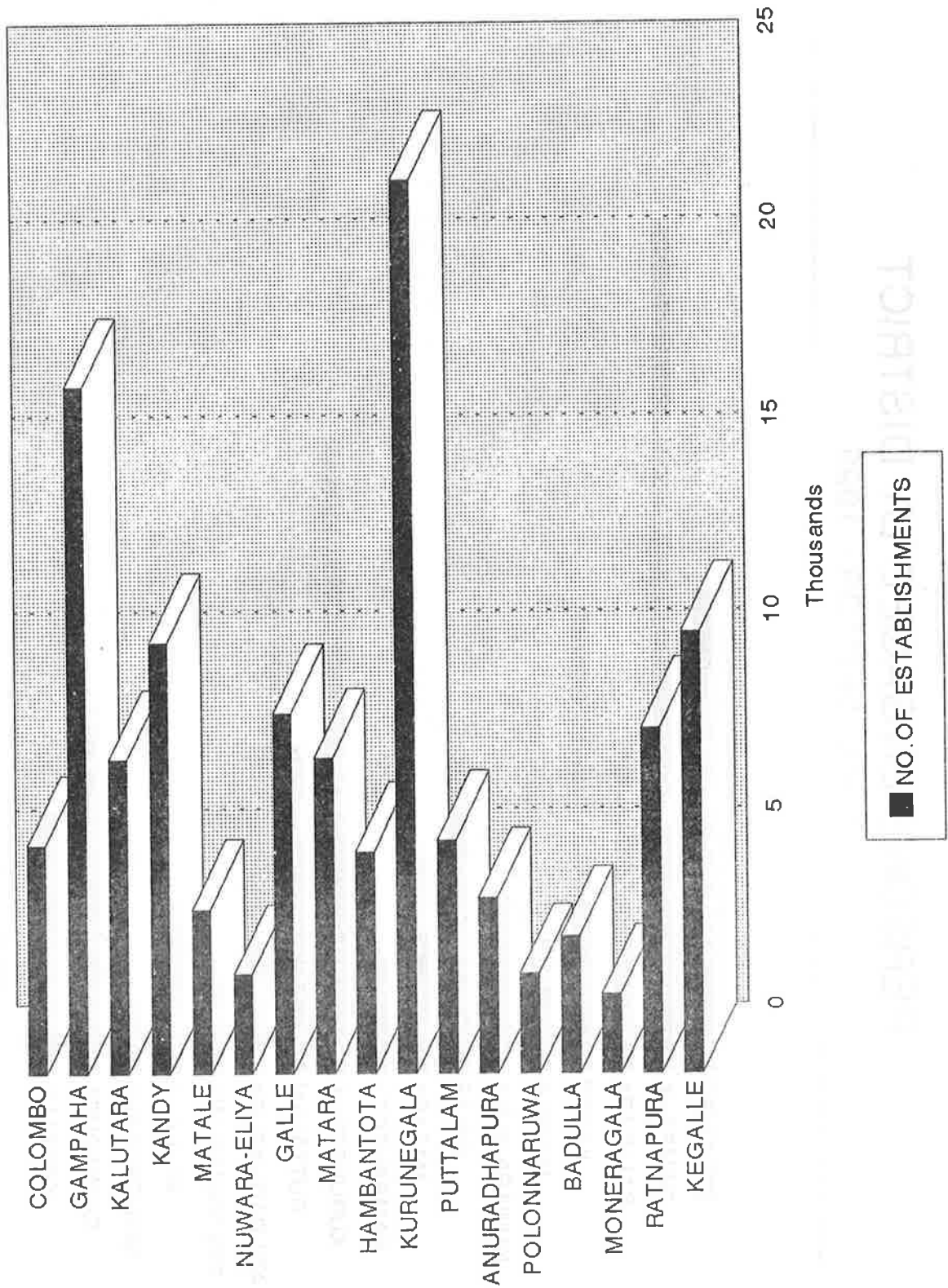

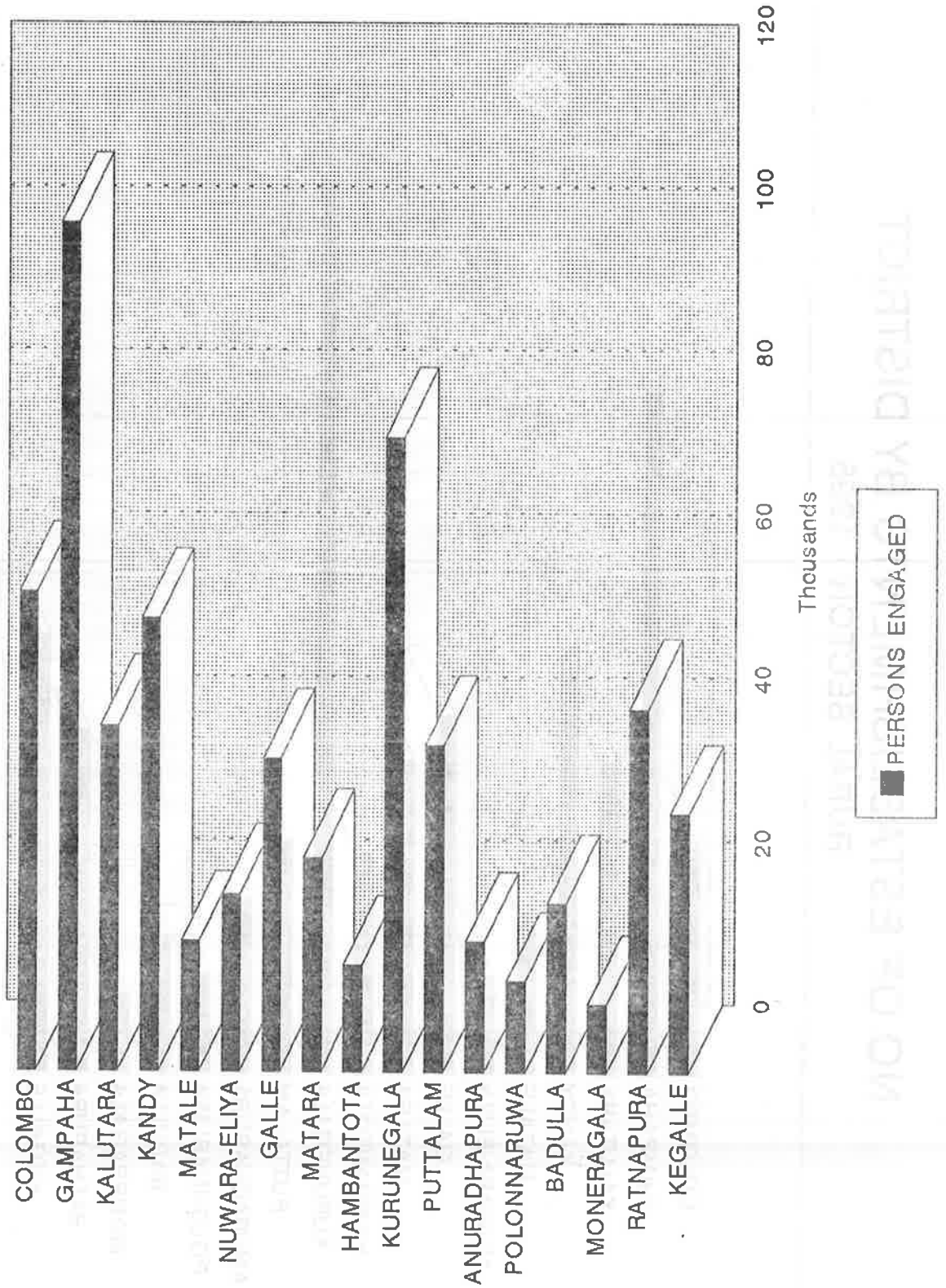

NO.OF ESTABLISHMENTS BY DISTRICT RURAL SECTOR - 1995

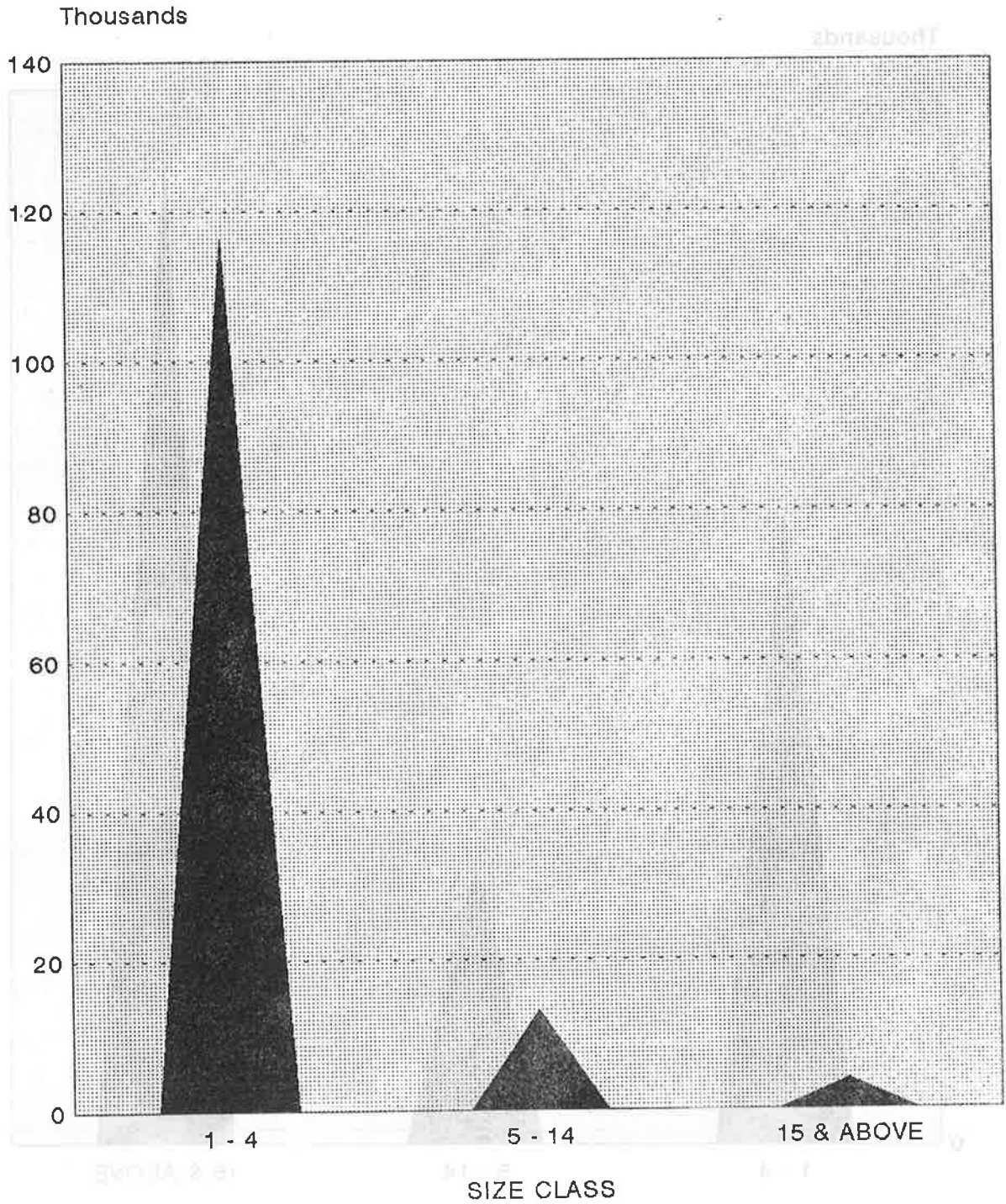


PERSONS ENGAGED BY DISTRICT RURAL SECTOR - 1995

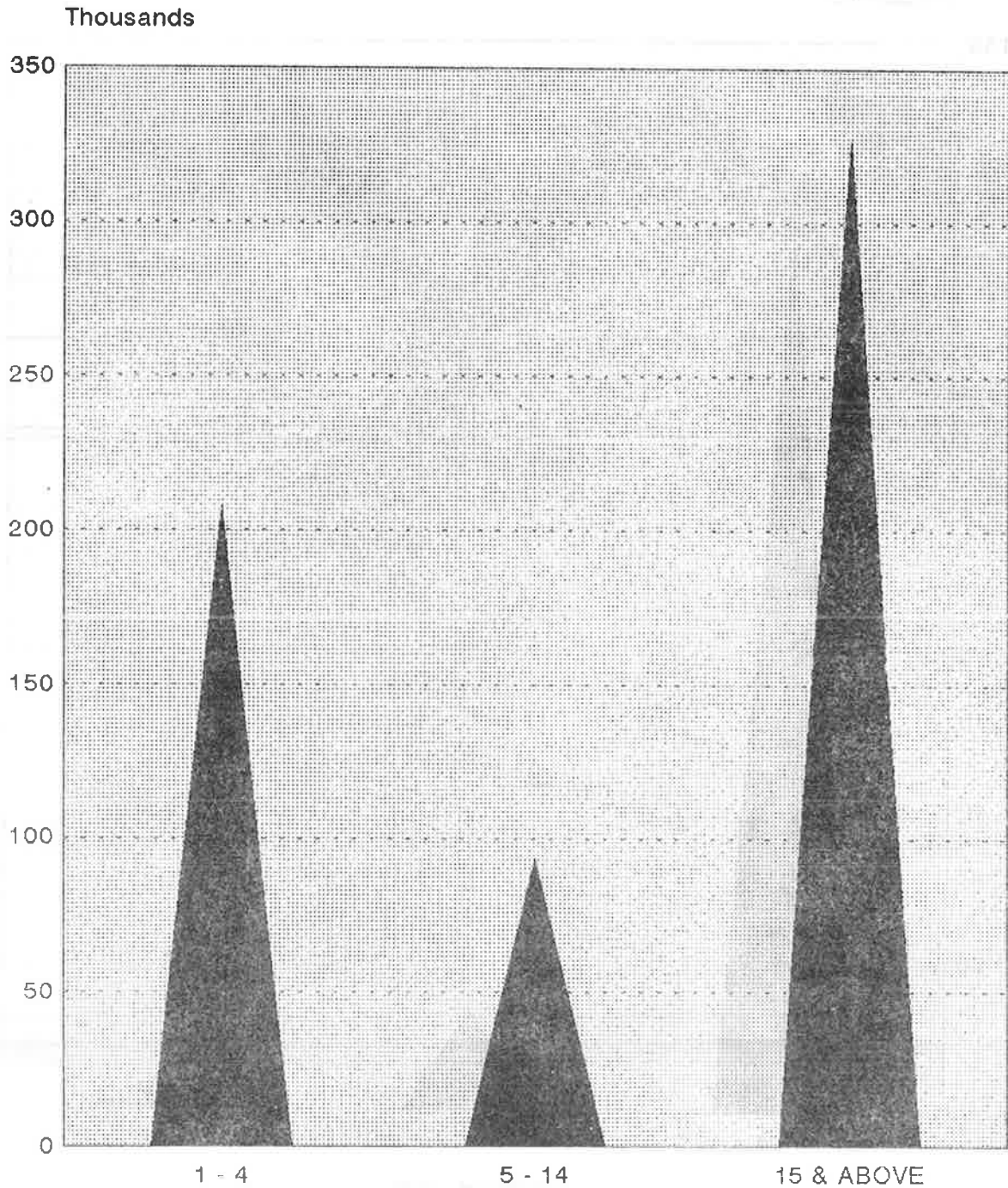

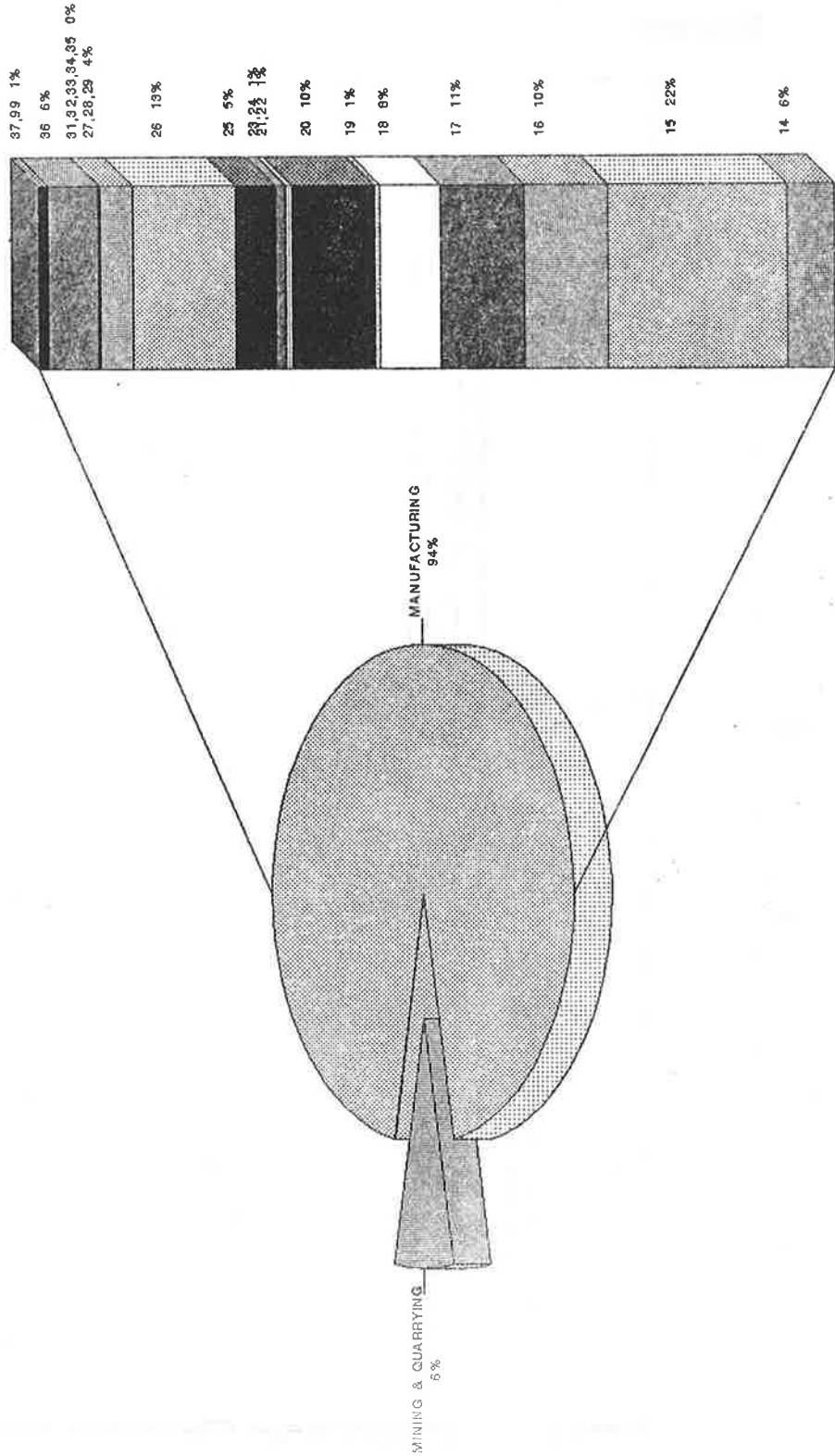

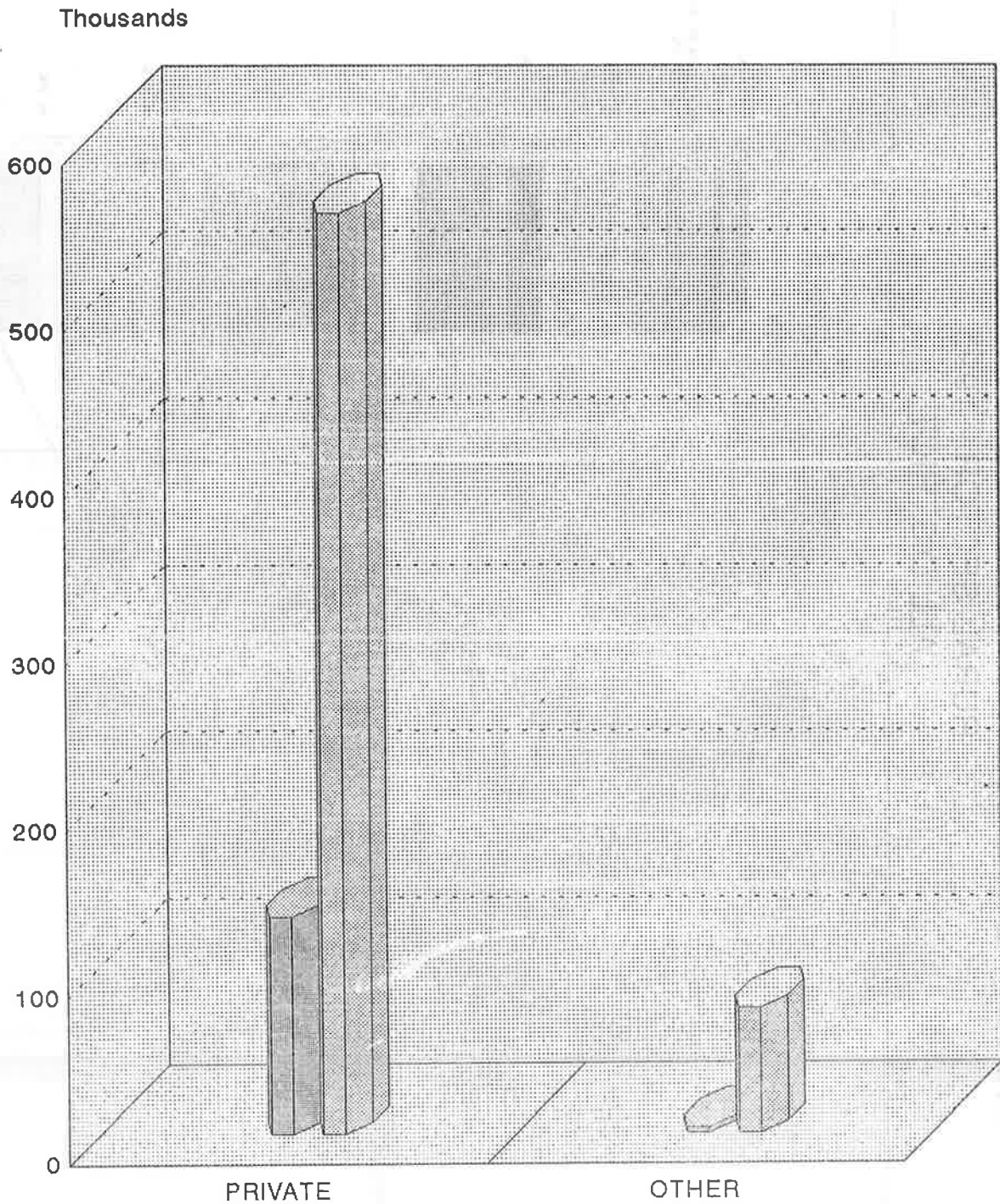
NO.OF ESTABLISHMENTS BY INDUSTRY DIVISION RURAL SECTOR - 1995 ALL DISTRICT
