Dear Madam,

Over 16 months have elapsed since the Government of Sri Lanka (GOSL) and the Liberation Tigers of Tamil Eelam (LTTE) entered into a Cease Fire Agreement (CFA) and signed a Memorandum of Understanding (MoU) in February 2002. The avowed aim of this agreement was to reach a negotiated settlement to the ethnic conflict that had bedevilled Sri Lanka for 25 years and restore peace and normalcy to all parts of the country.

It must be acknowledged that since February 2002 there have been no large scale armed confrontation between the LTTE and the Sri Lankan security forces although there have been a number of serious incidents between the Sri Lankan navy and the "Sea Tigers". LTTE has also abducted a number of soldiers and policemen.

However, the most alarming development in the last 16 months is the systematic campaign of political assassinations initiated by the LTTE. The LTTE has put into operation a well-planned campaign to physically eliminate elected officials, political organisers and even lapsed members of all Tamil political parties who have eschewed the terrorism of the LTTE and entered the democratic process. Amongst the victims of this reign of LTTE terror are members of the Eelam People's Revolutionary Liberation Front (EPRLF), the Eelam People's Democratic Party (EPDP) and the People's Liberation Organisation of Tamil Eelam (PLOTE). In the East of Sri Lanka the LTTE have so far killed 15 members of the EPRLF. In recent months the LTTE has gunned down,

stabbed or decapitated more than 40 members of the aforementioned Tamil democratic parties. Their campaign of murder and mayhem has not been confined only to current members of Tamil democratic parties. Even those members who have left politics long time ago are being targeted by the LTTE.

Recently, one of the most popular leaders of the EPRLF, Mr.Thambirajah Subathiran(Robert) was killed by a LTTE sniper right on the terrace of the EPRLF party office in Jaffna. The LTTE gunmen had entered a nearby girls' school opposite the EPRLF office and executed the sniper attack through one of the school windows. No doubt the fact is that Mr.Subathiran was a kind, soft-spoken man, a humanist and a democrat. He was much loved by the people and respected by other democratic parties. The large crowd that came to his funeral which included political leaders from almost all the major political parties, members of parliament, intellectuals, members of non governmental organizations (NGOs) and leading journalists amply expressed the indignation the people felt for the LTTE's attempt to politically 'cleanse' the Tamil community.

Apart from this campaign of assassinations, the LTTE has also continued their unrelenting campaign of abductions and kidnappings of political opponents and forced conscription of young children. Except for a handful of people who have managed to escape from the LTTE torture chambers, the fate of most men, women and children whom the LTTE has abducted is not known.

The body specifically set up to ensure that the LTTE and the GOSL comply with the terms of the Peace Accord is the Sri Lanka Monitoring Mission (SLMM). It comprises of members from the Scandinavian countries and is headed by Norway. However, the SLMM has done little to prevent members of the democratic Tamil parties falling victims to LTTE terror. Like the proverbial monkeys who 'speak no evil', 'see no evil' and 'hear no evil' the SLMM seems to turn a blind eye to the LTTE's campaign of low intensity terror. Moreover, the SLMM also ensures that the police are not able to take effective action against LTTE death squads. The government's deafening silence in order to ensure at any cost that the LTTE remain at the negotiating table

although they have now temporarily withdrawn from it, has only permitted the LTTE to carry out these atrocities unabated and accelerated.

Furthermore, we have also brought these assassinations to the attention of both the local and foreign Human Rights Organizations. Before he was killed Mr. Subathiran specifically sought the assistance of the international community to halt the LTTE's campaign of terror. But so far there has been little positive response from the international community either.

Very few local Human Rights Organizations have dared to report the atrocities of the LTTE. The exception has been the University Teachers for Human Rights, Jaffna (UTHR(J)) which has accurately and fearlessly published the barbaric acts committed by the LTTE exploiting the weaknesses of the MOU to impose its tyranny on the people. In addition, a statement too was issued recently by a group of Human Rights Activists and intellectuals condemning the political killings.

Clearly the peace that the LTTE is seeking is the peace of the graveyard - the "peace" that will give them absolute control in the North and the East of Sri Lanka. The LTTE is totally opposed to democracy, pluralism and respect for basic human rights.

Alas, except for one or two English and Sinhala newspapers, the media, and particularly the Tamil media function as craven apologists for the LTTE. Most human rights violations are seldom reported in the Tamil press. Tamil speaking people are denied the right to know what is happening in the country and what is going on at the peace talks. Only the LTTE-authorized versions of the news are made available to the Tamil the people. It is strange that organizations such as Article 19, which made such a hue and cry about minor transgressions on press freedom by the previous Sri Lankan government, have become tongue-tied in the face of the wholesale suppression by the LTTE, of free expression.

Unfortunately, the participation of Mr. Ian Martin, the former director of Amnesty International (AI) in the peace process, has also not produced any positive results. He could have played a more pro-active role in insisting that in any peace negotiations the protection of human rights should be an essential prerequisite.

No doubt organizations such as the Amnesty International too may have expected that the negotiations between the LTTE and the GOSL would usher a new era of peace and reconciliation between the major communities in Sri Lanka. While that is a laudable sentiment, the reality on the ground has been very different. The LTTE has deprived the Tamil and Muslim people in the North and East their human rights and democratic liberties.

Therefore we kindly and earnestly request all international human rights organizations such as the Amnesty International, Human Rights Watch and others to strongly and unequivocally condemn the present campaign of terror orchestrated by the LTTE and demand that the LTTE respects the human and democratic rights of all the people in Sri Lanka.

They must call a halt to the LTTE's campaign of murder, abduction, torture, extortion, unlawful confiscation of property and forced conscription of children.

We annex hereto a list of some of the victims of LTTE's atrocities since the Cease Fire Agreement (CFA) and the signing of the Memorandum of Understanding (MOU), for your information please.
