

EDITORIAL

PROPER FUNCTIONING OF PARLIAMENT AND LEGISLATURES

he capital city of New Delhi has witnessed a meeting of dignitaries who have expressed their anguish over disorderly nature in the functioning of Parliament and State Legislatures. They bemoaned about the falling standards in Parliament and State Legislatures and suggested some remedies and passed a few resolutions.

Apart from the Vice - President of the Indian Republic, the Prime Minister, the Lok Sabha Speaker - 300 delegates, 59 presiding members, 12 Chief Ministers, Leaders of the opposition in Lok Sabha and Rajya Sabha have assembled on 25.11.2001 and held a marathon session for 9 hours. Really they have made a history.

The marathon session has looked at the problem as a whole from the point of view of "Coalition Politics' that has come to stay between 1977 and 1999. But they have not gone deep into the reason that have brought India to such an unhealthy situation.

The simple and real reason for deterioration of standards in public and political life is that most of the national level parties and regional parties lack ideological goal and set programmes to achieve the ideology.

What is the ideology of the Indian National Congress which has ruled India for over 46 years from 1946 to 1976 and from 1980 to 1996 out of 54 years of the so called independence? The only intention of the Congress was that India should be ruled by a member of the Nehru family at any cost. That has happened for over 40 years. Other than a member of Nehru family there were Lal Bahadur Shastri between 1964 - 66 and P.V. Narasimha Rao between 1991 - 1996. They also belonged to uppercastes.

During such a long period of 46 years, what prevented the Indian National Congress from providing education to all citizens under 14 years of age under the provision laid down in the Directive Principles of State Policy in the Indian Constitution? The only reason was that the Congress which was a party of upper castes, of land lords, mill owners, bankers and advocates lacked ideological commitment and functioned as a party of men to enjoy all the benefits that were available in social, political and economic spheres of India. They aimed at keeping the largest majority of the toiling classes as illiterates and they have achieved it and nothing else. None of the other national level parties has given serious thought to this issue because such of those parties also were under the leadership of uppercastes and land lords. It is true that many

of them were Brahmins and a few of them professed Gandhian socialism and Marxian socialism,

through non-violent means.

How do the present day leaders expect that men and women of standards should take part in politics and lead the nation on right lines? What right these leaders have to bemoan over the falling of standards? The Parliamentarians and Legislators are elected by men and women who have not been taught in schools as to what is democracy and what are the functions of Parliament, Legislatures, the Executive, and the Judiciary. The print media which is available to the people does not allow the people to sift the right from the wrong and learn good things. The political parties have not enlightened their respective cadres as to the functions of the Government and the duties of the citizens. The nett result is that caste - leaders, black marketeers, contractors and those who are near and dear to the concerned political party leaders are distributed seats, supplied men and material during elections and such men who employ these effectively get elected and become Parliamentarians and Legislators.

Most of the 543 Lok Sabha members and the 4,000 State Legislators that get elected are

composed of men and women of these categories and qualities.

When such people are elected they are not given sufficient orientation about Indian constitution, May's Parliamentary procedure and other related rules and regulations compulsorily. Those who deliberated on the 25th of Nov. 2001 at New Delhi on these matters have expressed their willingness to do it. But it is a fact that it has not been done compulsorily though such a provision was there already.

The concerned political parties excepting the Communist parties are not particular in equipping their members of Parliament and Legislators on the necessity to study the reports given to them during the sessions - and discuss and interact among themselves on the subjects

of those reports.

The most important lacuna in the proper functioning of Parliament is that the number of days of sitting has been cut and instead committee system has been introduced during 1991-1996. The members of the committees are very particular in undertaking tours within and outside India at the cost of the Govt and getting fabulous amounts as sitting and travelling allowances. This is mostly because they lack knowledge on the issue or subject for which the committee is constituted.

For example there was no debate in Parliament on the issue of accepting the W.T.O. stipulations laid down by the Dunkel Draft, during 1991 - 1996. The committee entrusted with that task also failed to do justice to the issue. Further more neither the Indian National Congress nor the other national parties had taken initiative to take up the matter to the public and disperse knowledge to the farmers, traders and small industrialists on the impending dangers that will befall and oppress the intersts of India.

Without giving deep thought to the problems of illiteracy, poverty and unemployment any

effort taken by the higher ups to tame the Parliamentarians and Legislators will prove utterly

For example there are over 240 land reform legislations passed by the States in India between 1950 and 1986. All these legislations have been put under the IX Schedule and made non - justiciable. The immediate result was that implementation of land reforms were totally left to the mercy of the executive wing and the Government. It is a pity that none of the States except West Bengal, Kerala and Tripura, had given any thought to this problem for over 51 years, after 1950. As a result in a country where 65% of the total population is dependent on agriculture, most of the actual tillers and toilers have been left landless labourers. This is horrible, even for a minute to think. This pathetic situation has been caused wantonly by the ruling classes - both in the Government and in the executive wing who did not have the necessary will and determination and intention to chalk out meaningful measures to carry out the reforms within a stipulated period of time. Further since most of those at the top of the helm of affairs were upper caste - cum - rich landowners, they were conciously opposed to land reforms and worked for its failure.

Unless the Parliamentarians and the Legislators are made aware of such things, where is the

hope of making them to work in the interest of the nation and the people?

These are the root causes for mushrooming of innumerable parties and political groups at the national and regional levels. As long as there are possibilities for sprouting of many number of parties there cannot be polarisation of parties into two, three or four on ideological lines. As long as there are dozens of national parties and many hundreds of regional and caste based political groups, coalition set up of Governments will be the only way. Coalition with concensus on vital issues is the most dangerous aspect in politics. That becomes much more dangerous when most of the parties do not have ideology.

It is certain that the Congress stands for status - quoism in social, political and economic spheres. It is further more worse that it has turned around to the mercy of Nehru family for its

Still worse is the Bharatiya Janata Party which has declared to establish "Ram Rajya' which is anterior to status - quoism. Under such circumstances the people of India are destined to get deprived of all the benefits that are due to them under these two evil political forces.

It is nothing but simply white washing the parliamentary issues under the garb of giving serious thought to the deterioration of "Discipline and Decorum in Parliament and State Legislatures". It was a wasteful excercise.

Because of the failure of the Govt of India on all fronts during the past five decades, only half - educated, ill-equipped and self - centred thieves, rowdies, murderers, rapists and religious and caste fanatics will enter into the Parliament and State Legislatures. As a result utter chaos will accrue and bloody revolution will burst out.

Self Respect Movement

"What is the necessity for a self respect movement? From the time of the Kanchipuram Tamil Nadu Political Conference, I have been speaking and writing about the need for a movement to preserve our self respect. Because all of you accepted it and welcomed it my opinion has been strengthened. I have come today in consideration of the above facts. I have spoken about the purpose and ideology of the movement once or twice when I came

here before."

"You all know that we are 22 cores strong. Inspite of this a group of small numbers are treating us worse than animals, insects or worms, because we belong to a caste which is low and despised. To remove this stigma our forefathers have taken many actions over thousands of years. To remove our degradation, Buddha, Kapilar, Ramanujar and other greatmen took birth and died for this. But we, because of our low status and degradation and lack of self respect have fallen prey to brahmins who with cunning used some of our people to frustrate all our efforts. However we were defeated or degraded we have fought back again and again to overcome our disabilities, day by day our desire to be free has grown. The opinion of the people has also been steady. This is the time to shake off our yoke and gain our self respect. We must all be united on this matter and work hard to win."

"The brahmins and their hirelings will try to frustrate our attempts with lies and fraud. Our own people under the garb of patriotism will work against us for earning their livelihood. We should not take them seriously."

"Are we thinking of hurting any one? Are we taking away any one's freedom? We are working for our self respect and not against anyone else's self respect. If we bolt our doors and protect our goods, are we hurting the thieves who want to rob us? Will we be guilty of starving them? Will this not help to make the thief learn a lesson that he can't live by robbery and change his ways? If the thief is angry with us what can we do? Should we not win self respect or not? We have to think of our self respect and not care about what the others say. Sir. C.P. Ramasamy lyer who is a member of the legislature and in every cell and breath a brahmin, speaking at the Nadar conference last year as

Chairman, said:

"We Indians say that in politics and commerce we should not allow the Europeans to be above us and we must be on par with them. The Indian Congress and Muslim League from the beginning have said this and are working to achieve this. In the same way, some who by accident or unfortunately are considered of lower rank are fighting with the upper classes to be equal to them. This fighting is justified. It is very customs have to be abandoned and is natural. These are necessary to achieve equality among communities. People with foresight will realise this."

Comrades,

"Self Respect movement was started to make people be ashamed of their position. It is meant to reform society. This change has to come through revolution and not through plays and laughter. We have to undergo suffering."

"We are degrading and harming ourselves. If we do not correct ourselves, our society will never be redeemed.

There is not only high caste and low caste, there is high and low in men and women too. Further there is rich and poor. Employer and employee. It is said these are natural, not made by man but ordained by god. People who are high say this and people who are low accept this.

It is false beliefs that have prevented reform in society.

If it is believed high and low castes and all sufferings there to are god made, who will dare to change this?

The high caste man is proud of himself, he is degrading and harming those below him. This nature is not only in brahmins but in every other caste.

They consider reform of castes us evil. Mixing of castes is equated to prostitution. This outlook is very death to abolition of castes.

Remember that there is nothing else than self respect movment to destroy caste foundation.

Thiruvalluvar, Kapilar, Ramanujar of puranic age and Brahma Samaj and Arya samaj of our times without knowing the truth were only tinkering with castes, only to silence society and the world. They never did anything to abolish castes.

Therefore no one has attempted to wipe out castes. Even attempts by some pople are only to raise their caste status. Even mixed castes are unhappy that they can't call themselves "a caste'. They are not worried about abolition of castes. All these troubles can be removed only by self respect movement. All other reforms will not be helpful.

Muslims consider self respect movement as alheist. They are not worried about it themselves, they only want to show others that they are with them. They are frightened, otherwise they will be harmed. To Muslims and others who join self respect movement I say that there is no atheism in our policies.

There is room in self respect movement for all religions and aspiration. Its ideal is this "to remove all false beliefs, meaningless rituals and all vain expenses on these."

To remove all separation due to religion, caste and class, to remove all differences in economic and social spheres and make society a homogeneous brotherhood.

To be bound by reason and self espect, and follow self respect ways. What relationship exists between these and theistic and atheistic ideas? Thiestic and atheistic is individuals view and conduct. There is nothing atheistic in joint action of Muslims and Tamils."

Comrades,

"Self Respectors seek to instill a sense of decency in people, to establish equality among all socially and economically. It has other policies but they are not against god and religion.

If any god, religion or any other force tries to obstruct our work, self respect movement will not hesitate to destroy them."

Sudras, non-brahmins and chandalas do not know head or tail of these matters. Only those with idea of freedom and self respect and those who are twice-born can reason out these things. Before they were born they were not aware of the tragic state of their parents or society. I will give an example of about 30, 35 years ago (1938).

My father was a municipal councillor and a prominent trader in Erode. He paid about 100, 150 rupees as income tax. One day a brahmin who drew a monthly salary of Rs. 12.5 to Rs.15/- came to make an enquiry about income tax. My father stood up and said "welcome, welcome, swami!" with folded raised hands and asked the brahmin to sit and my father was standing. That brahmin, a bill collector said rudely "adail Venkata Naikka, shall we go and inspect that house?" My father tied his turban and followed the brahmin. On his return my father bundled saffron, chillies,

palmya sugar in a bag and sent a man to deliver the bundle, at the brahmin's house. This I saw with my own eyes.

Similarly great land owners, advocates, officers were treated rudely, worse than dogs by brahmins. All these I have seen myself. Do you see the difference then and now?

The condition of religion and brahmins before and after self respect movement started and the changes that have come will be understood by people with feeling."

Ideals of Dravida Kazhagam,

Chairman, Comrades!

"Like the Congress party, the Communist party, Republican party, Hindu Mahasaba and other parties, the Dravida Kazhagam is not a political party. But other parties do not accept this. Like many other ignorant beliefs in our country this too is due to ignorance.

Dravida Kazhagam is a reform movement to destroy false beliefs in gods, religion, hell and heaven, swaraj and ideals of high and low castes and bring unity, discipline, and sense of fairness in society. It is working for the good of all Dravidians including those in other parties.

Our first task is to teach feeling of nationality to Dravidians who have for long ages been kept in ignorance by vested interests. The second task is to destory their degradation and sudra status. If the other parties support us in these tasks we will hold them in respect. To our knowledge no party has come forward to take up these tasks. Not only have they come forward, they even redicule us. Some parties want to destroy us. If any party will take over these tasks we have no objection to disband Dravida Kazhagam. Let them say. We will disband.

If this swaraj government declares, "There will he no sudras, there will be no brahmins in this country we will disband our Kazhagam. We have told this very clearly many times before. Let even Hindu Mahasaba say, "We will not tolerate the existence of sudras or brahmins, there will be no distinctions of castes, there will be no laws, sastras, puranas and gods who advocate this distinction, We will disband our Kazhagam immediately and join Hindu Maha Saba. In contrast the brahmins who call themselves high caste have helped to promote this degradation. These are the people who came as Rama, Krishna, Narasimha and destroyed our great reformers, They were killed by the power of god. Through fear of hell, false beliefs were spread among the people, rational thought was extinguished.

This scared group will try to destroy the rationalists. If they fail they will praise them as super human. They will wait for the right time and take him to the sacred feet of the Lord. That is how Gandhi was killed. His fate is an example. Not only they, I too, if I was one of them will do the same. If

the structure of society is that all the benefits of work must come to the lazy people, will I say this must be changed? If others try to reform this, will I allow them to do it? Even in this age when workers are powerful can reform be checked? It must be changed. Till this change occurs we are not worried about ruling the country. We are not worried so and so or a particular group should rule. We are not worried if a Negro rules us or like in Ramayana two slippers rule us. Who ever rules us, we want him to be a gentleman who will respect our human feelings. The Government of today can't be called swaraj Government. What we have is Congress rule. Today's rule is not people's rule. It is Manudharma rule. It is purely brahmin rule. In brahmin rule we have to drink urine and dung as a religious rite. If we condemn this, they will say we are anti-religious. If we say, we have to suffer and die, even in swaraj rule, we will be sudras. Why should swaraj rule exploit people? They will say this is anti-government. Further what we have got is not swaraj. You must know it is a colonial government with some powers transferred. Even this power is in the hands of the brahmins, not in the hands of common people. What did the congress promise us when they took our votes? They promised swaraj. When they found swaraj is not possible, like genglemen, they should have resigned. Should not what you voted for have been given to you? Instead they are using the power they got, for their self interest. Is this just? Is it not political deceit?

We gave our votes to shake off our sudra status. We wanted to rule our country. We wanted aliens to quie. We wanted to get rid of his exploitation. You call us anti - government. Is our land poor in resources? Don't trouble your-self. Give us separation.' (Speech at Vellore, 12.3.1948) Viduthalai 15.03.1948)



everish canvassing is in progress in Sri Lanka for the General Elections fixed for 5.12.2001. On the advice of Liberation Tigers of Tamil Eelam, four Eelam Tamil Political parties have formed a united front under a common symbol, "the rising sun' to contest in the General Elections on 5.12.2001. The parties are Tamil United Liberation Front (TULF), Tamil Congress (T.C), Eelam People's Revolutionary Front (EPRLF) - (Suresh faction) and Tamil Eelam* Liberation Organisation (TELO). This is certainly a striking improvement. But Eelam People Democratic Party led by Douglas Devananda is staying out and supporting Chandrika. People Liberation Organisation of Tamil Eelam has not taken a decision.

Earlier Elections:

It is interesting and instructive to look back at earlier elections, before we take up the forth coming elections. Since independence in 1948, eleven general Elections have been held in Sri Lanka. A notable Eelam Tamils have consistantly, at great suffering to themselves, always supported the candidates who promised freedom to them.

In this context the 1977 General Election is a water shed in the history of Sri Lanka. Backed to the hilt by U.S.A., J.R. Jayawardena won a landslide victory. But a more vital victory was that of the Tamil United Liberation Front which won 17 seats and became the opposition in Sri Lanka Parliament.

Jayawardana and his murderous gang could not stomach this. They let loose three genocidal racial attacks on Tamils in 1977, 1981 and 1983. The division between Singhalese and and Tamils became permanent. Prabakaran took up the challenge and started guerilla war.

The general elections due in 1982 was not held. Jayawardena wanted to become a dictator. He drafted

the Presidential constitution, held a referendum and installed himself as Dictator. The irony of fate is that Prof. A.J. Wilson, son-in-law of Thanthai Chelva drafted this constitution.

In 1988 Jayawardena retired, and feature in these elections is that the General Election and provincial elections for North and East were held. The Indian peace keeping force supervised the elections in North and East. All kinds of malpractices were employed and a congenial quisling, Varadarajah Perumal was installed as Chief Minister of North and East. This is the darkest hour of Indian political and military escapade in Sri Lanka. How India can again try to interfere in Tamil Eelam affairs is beyond comprehension. Premadasa won the 1988 elections and became President. He was killed in 1994.

> In the 1994 General Elections, Chandrika became Prime Minister. The 1994 elections in Tamil Eelam aré a disgrace to Chandrika and the Singhalese. Who are the Naxalites?

In March 1967, peasants in Naxalbari, a hilly region in northern West Bengal, forcibly occupied lands and took away paddy belonging to jotedars (big landowners). In the next two months, animals and implements were seized by the peasants, land deeds and other documents of the jotedars were burnt and land was redistributed among the landless poor. The Naxalbari uprising was master-minded by Charu Mazumdar and implemented by Kanu Sanyal, both Communists with radical ideas. Charu Mazumdar called for more armed peasant uprising on the Naxalbari model, and his followers came to be called Naxalites.


Do Naxalites belong to any political party?

Charu Mazumdar and others formed the Communist Party of India (Marxist - Leninist) in April 1969 but the party has never been given official recognition.

The Central and the West Bengal governments came down heavily on the Naxalites. Charu Mazumdar was arrested in July 1972 and died shortly afterwards. After his death, the Naxalite movement petered out in Bengal but took root in other parts, notably Andhra Pradesh.

What the Brahmins did to defend, propagate and elaborate "Purusha Sükta"

was not done by the Tamils to Thirukkural

"The social order prescribed by the "Purusha Sukta' has never been questioned by any one except Buddha. Even Buddha was not able to shake it for the simple reason that both after the fall of Buddhism and even during the period of Buddhism there were enough law givers, who made it their business not only to defend the ideal of the "Purusha Sukta' but to propagate it and to elaborate it..." (Dr. B.R. Ambedkar, who were the Sudras? 1946)

When Mr. Ram Raj (rechristened Udit Raj now), an Indian Revenue Service officer, led members of the All India Confederation of SC/ST embrace Organisations to Buddhism on November 4, 2001, he was only following a prescription handed out by Babasaheb Ambedkar a couple of months before his demise, in December 1956, to embrace Buddhism. Since then, scores of Dalits have been declaring themselves Buddhists in their own way.

Ambedkar's was indeed a demonstrative action against the Brahmanical Hindu social order, of which the concept of "Purusha Sukta' served as the basis.

This, according to Ambedkar, was unique for the wrong reasons. "Purusha Sukta' made the Hindu social order unique because ""it preaches a class composed society as its ideal". And the idea of enmasse conversion of Dalits to Buddhism was a revolt against the Hindu social order and its priests.

One of those who grew up in the radical political millieu of New Delhi's Jawaharlal Nehru University in the 1980s, Mr. Raj certainly could not have not known that Ambedkar's prescription was merely symbolic.

And the developments since then - especially the coming of age of an exclusivism as the most pronounced form of Dalit assertion - in the Indian political discourse could not have been missed out by the angry young man that Mr. Raj was when he left the University campus to join the IRS.

The Dalit Soshit Samaj Sangarsh Samiti (DS4 as it was known then), founded by Mr. Kanshi Ram in 1984 and representing mostly Dalit Union and State Government employees, had transformed itself into the Bahujan Samaj Party (BSP), and shocked political observers when it

polled more than 10 per cent of the votes in the 1989 Uttar Pradesh Assembly elections.

Mr. Kanshi Ram dld not show any enthusiasm for organising conversions. He also refrained from raising the issue of land owenership (despite being aware that a majority of the landless farm workers were Dalits)

Instead, he went about declaring that the Bahujan Samaj was in no way going to make a fetish of the ideological moorings of the mainstream political platforms; and he displayed this by striking alliances with parties across the spectrum. This, he has maintained, is the means to empower the Dalits.

With the benefit of hindsight, one can conclude that the BSP could consolidate into a political force to reckon with only because Mr. Kanshi Ram refused to challenge the oppressive landholding pattern in the Gangetic basin.

After all, one has seen the violence unleashed against the CPI (ML - Liberation) which internalised the question of land rights into the Dalit question in neighbouring Bihar.

The point here is that the agenda of Dalit assertion has now matured, thanks to the BSP's emergence, in such a fashion that the symbolism that marked Ambedkar's prescription (though en masse conversion may have been relevant in his time) is no longer of any

significance. What is needed is a platform that challenges the land - owning patterns in the rural areas.

This is easier said than done. Experience has shown that the status Quoists will refuse to give in without a fight. But then Mr. Raj's objective of serving the Dalits' cause will be

realised in a meaningful fashion only if he wages the battle with a strategy determined by the objective reality. To orchestrate *en masse* conversions at this stage will only constitute a ritual and nothing more.

AMBEDKAR SLAMS INDIA'S POOR PERFORMANCE

Dr. B.R. Ambedkar, who resigned as Law Minister from the Government of India, spoke to students of Lucknow University on the 8th, and cited a number of instances of poor performance by India which foreboded a dark future if the dangerous drift was not drastically and soonest corrected. He said, "The Government's foreign policy has failed to make India stronger and stronger: why should not India get a permanent seat in the U.N. Security Council? Why has the Prime Minister not tried for it? India must choose between parliamentary democracy and the Communist way of dictatorship and come to a final conclusion." Replying to various questions, Dr. Ambedkar observed: ""I am very pessimistic about the future of our country. Foregin countries do not consider us as important. Internally, the administration has completely deteriorated. Corruption and nepotism are rampant, and the Congress High Command has not ordered any enquiry against Ministers who are accused by even Congressmen. On the other hand, those Ministers are protected... We talk of shortage of food and cloth, but we must remember that there is very serious shortage of great leaders... What has happened to the economy of India? Every year we seem to have a famine; are we going to die like flies?... It may be much better to live in anarchy, than in a country where Government cannot tackle even vital problem like food... Our population is increasing enormously, and the numbers may soon exceed our capacity to supply sustenance to the masses.'
